TERMS AND CONDITIONS

*Person having Personal account with **Kuber Merchant Finance Limited**. (herein after referred to as the "Bank") may avail ATM facility from the Automated Teller Machine (herein after referred to as "ATM") in branches and/or any ATM counters under SCT network where ATM are set up by using Kuber Easy Cash Card (herein after referred to as "CARD") subject to the following terms and conditions:*

1. The Cash Card and the Personal Identification Number (herein after referred as "PIN") slips shall be issued to the Account Holder (Card Holder) at his/her sole risk & responsibility and understand not to pass or disclose the pin to other person.
2. The card is not transferable and shall be used exclusively by the CARD HOLDER. The Card Holder undertakes to destroy the PIN slip after memorizing the PIN Number.
3. The Card Holder is allowed to withdraw cash within the arranged limit and make payment for his/her purchase to the merchant throughout Point of Sale (herein after referred to as "POS") by using this card.
4. The Card Holder will be provided following facilities through ATM with the help of this card:
a) Language Selection b) Cash Withdrawal c)Fast Cash d) Balance Enquiry e) Others: i) PIN Change ii) Mini Statement
5. The CARD HOLDER undertakes to notify the Bank in writing of any loss, damage or theft of the card or disclosure of the PIN and hereby agrees to be liable for all the transactions made by the use of the card prior to the receipt of such written notice by the Bank.
6. The Bank shall debit the designated account of the CARD HOLDER for all transactions initiated including cash withdrawal by using the card. For this purpose, the CARD HOLDER irrevocably authorizes the Bank to debit his/her designated account affected through the use of his/her card.
7. The Bank shall determine the minimum balance required to maintain in designated account of the CARD HOLDER for the use of ATM facility of the Bank. The CARD HOLDER agrees to pay applicable ledger fee in case of withdrawal away from such amount.
8. The Bank shall debit the designated account for all fees and charges as determined by the Bank relating to the Card and the services thereby provided.
9. Cash withdrawal from ATM will dispense denomination as decided by the bank management in view of economic circumstances & usage of the card will be limited to debit only. No electronic (ATM) deposits may be made by using this card.
10. Wrong entry of PIN for more than three consecutive times while making cash withdrawal will automatically make the card out of use. In such cases the CARD HOLDER will have to contact to the concerned authority for making the card revalidated for operation.
11. Any mistake in the transaction slip has to be reported to the bank by the Card Holder immediately. The CARD HOLDER further undertakes to accept full responsibility for all the transactions made by the use of card whether or not made with his/her knowledge or authority and he/she shall accept the bank's record of transactions as binding for all purposes.
12. For Joint Accounts, which are operated on the signature of anyone of the account members, only one card will be issued against the account. The joint account members will be jointly and severally binding on all account members and as the context requires, terms herein denoting the singular shall include the plural and vice versa.
13. The Card issued to the CARD HOLDER shall remain, at all times, the property of the bank and shall be surrendered to the bank on demand. The bank at its sole discretion reserves the right, at any time, to cancel or withdraw the card or refuse to re-issue, renew or replace the card without assigning any reason.
14. The Bank shall not be responsible in any way for non-availability of ATM services or POS terminals in any merchant outlets for any reason whatsoever and howsoever arising as a consequence of malfunctioning of the card or ATM, mechanical or power failure or otherwise.
15. All fees related to card are payable in advance as per the bank's prevailing tariff and bank shall debit the designated account maintained with us.
16. The Bank reserves the right to amend these terms and conditions at any time without prior notice to the CARD HOLDER and such amended terms and conditions shall be binding on to the Card Holder.
17. The CARD HOLDER undertakes to indemnify the Bank against all losses, damages, cost or expenses incurred and sustained by the Bank due to the Card Holder's failure to observe any of the terms and conditions herein mentioned.
